Pre-Kindergarten Program Update

At 11:31 a.m. Associate Superintendent Student Services M. Perdue joined the meeting to provide an update to the pre-kindergarten programs within Chinook's Edge. At this time there are six schools that offer pre-kindergarten. In 2019/2020 there were a total of 183 Program Unit Funded children in Chinook's Edge.

In Bowden, Spruce View and Elnora, the community playschools are housed in schools (the space is leased) and PUF programming has been supported in a developmentally appropriate setting.

In other communities Chinook's Edge accesses offsite playschool placement in a local playschool (Delburne, Carstairs) or program for these young students. Chinook's Edge may also direct students to their nearest pre-kindergarten site (ie: Poplar Ridge goes to École Steffie Woima).

The costs of pre-kindergarten are covered by student registrations. Educational Assistant time, supplies/materials, PD and specialized professionals are paid from PUF and ECS mild/moderate grants.

Moving into next year numbers are changing. École Steffie Woima is moving to two classes and Jessie Duncan is moving to one. There is an increase in the number of hours for the students to 400 hours.

Associate Superintendent Student Services M. Perdue shared with the Board that prekindergarten addresses specific student needs and provides support to better prepare young children for success in kindergarten. As well, other children from the community have traditionally been able to join these classes as space permits.

Associate Superintendent Student Services M. Perdue asked for the Board's support to implement a fee of \$200.00 for community children who do not qualify for other funding and are eligible to attend Pre-Kindergarten within Chinook's Edge.
